✓ Low Severity Issues

1. Out of gas

Issue:

- (MultiVesting) The function `withdrawAllAvailable()`, `getAvailableAmountAggregated()` uses the loop to iterate through `vestingMap`. Function will be aborted with `OUT_OF_GAS` exception if there will be a long vestings list.

Recommendation:

Check that the array length is not too big.

Notes:

- Stage 10-12 token rate equals to 10000.

Owner privileges (In the period when the owner is not renounced)

- **Crowdsale_NTM:**
 - Owner can withdraw contract tokens.
 - Owner can start/stop `_icoActive` and `chLink`.
 - Owner can change `_baseBNBPrice`.
- **MultiVesting:**
 - Owner can create vesting for beneficiary.
 - Owner can change `permittedContract` address.
 - Owner can withdraw unallocated funds.
- **NFT Moon Metaverse:**
 - Owner can pause/unpause contract.

Conclusion

Smart contracts contain low severity issues! Liquidity pair contract's security is not checked due to out of scope.

Liquidity locking details are **NOT** provided by the team.
